The perspective Bidder should be in a position to undertake the job as per the given Specifications and complete the work within the prescribed time schedule.

#### Instruction to Bidder and General Terms & Conditions:

#### **LIGIBILITY CRITERIA:**

- 2. In case of any discrepancy or loss arise: appropriate penalty shall be imposed, after assessing the extent of loss suffered by the ISHS.

#### TERMS AND CONDITIONS FOR TECHNICAL BID AND FINANCIAL BID:

- 2. **Preparation of Bids:** The offer / Bid should be submitted in two bid system (i.e. Technical Bid and Financial Bid )
